There are several great reasons why you should go to the CVR Watkins Glen Drivers' Education event on June 17-18.

Watkins Glen is not just for drivers. For family members who don't participate in DE just yet, there is plenty of fun to be had, other than just spectating at the track. Come up early on Sunday and spend the day exploring the area.

From lounging around at the beautiful Harbor View Hotel, taking a boat ride on Seneca Lake, hiking up the gorge trail to see the falls, window shopping downtown (you never know what souvenir you just might find), or taking a wine tour (or several) at the many local wineries Watkins Glen has to offer, there is something for just about everyone. There is even a WalMart. There are multiple ice cream shops in the area – I've tried most of them and they are all great.

The first real reason why you should come to the CVR WGI DE is a no brainer: if you have not been to WGI yet, you are missing out on probably one of the best tracks in the country. The track offers fun, exciting and adrenalin-pumping driving, with 3.37 miles of pavement, 11 corners, plenty of elevation changes and a set of thrilling esses. After the driving part of the event ends on Monday, we offer a track walk - if you've never done one, it is not to be missed. Technically, it's more of a track drive and park, drive and park, drive and park. You will be surprised at the elevation changes that feel so flat when you are driving the track in your car. It's fun to look back down a hill that you only see going up while driving and checking out the banking on the corners. After the track walk, there is a dinner at the WGI Media Center. It's a great way to unwind after a fun day of driving. I've heard drivers discussing every turn and pass that occurred during the event, all said with smiles.

The first real reason why you should come to the CVR WGI DE is a no brainer: if you have not been to WGI yet, you are missing out on probably one of the best tracks in the country.

This is a favorite event for many so be sure to register early, especially if you are in the Green or Yellow rungroups. We combine Green and Yellow Instructed into one rungroup – the track can fit 50 cars easily and still not feel crowded. We have great instructors to instruct the beginner drivers and to "help" those advanced drivers who just want to bring it up a notch. Look for registration to open soon. Remember, with your support, the CVR DE program is successful.

DE is all about safety and FUN! Register for a DE event and we'll see you at the track.

## THE FINE PRINT AM I COVERED WHILE DRIVING ON-TRACK?

Each year Porsche Club of America Regions organize many high-performance drivers' education events. Over the years PCA has earned a tremendous reputation for putting on educational, safe, and structured events. These events target what PCA members are most passionate about – appreciating the fine automobiles they own in a way that just can't be recognized in daily street driving.

For many years PCA driving enthusiasts had a sense of comfort knowing that their standard auto policies covered them while participating in PCA Drivers' Education events. Most policies had language that only excluded coverage while participating in "timed or competition events." Since PCA DEs are educational in nature and untimed, most insurers would pay for damages incurred at these events. Incidents causing damage to vehicles at PCA DEs are rare, but when they do happen the damage can be significant.

Around the 2003-2004 timeframe, it seems that many insurance underwriters recognized the additional exposure presented by individuals involved in DEs and modified their exclusions section accordingly. At the beginning, a few companies implemented new language to exclude coverage "on a surface used for racing", "in a performance driving event", or even worse "at a racetrack facility." Since the initial rollout of the exclusions, it seems that the majority of auto insurers have followed suit with these restrictive exclusions for individuals involved in DEs.

Many PCA DE enthusiast members have researched this topic in the past, prior to 2003, and believe that they are still covered while driving in events. Enthusiasts must understand that insurers do have the ability to change policy terms at each policy renewal. The typical policy holder receives their renewal, looks at the bill, and sends a check to renew their policy. In the pages following that bill, insurers include a coverage update that details any policy changes. Unfortunately these changes often go unnoticed by insurance consumers.


For individuals involved in DEs, it is very important to review your policy before you go to your next track event. Many insurance consumers don't file their current policies, but insurance agents will always send a copy of the current policy upon request. A quick review of the exclusions section of the policy typically reveals any language targeted at eliminating coverage while participating in events held at racetracks. Enthusiasts' vehicles are often the most treasured property they own, so it is important that they do their research and understand whether coverage is included under their standard policy while participating in DE events.

DE Participants that do not have coverage under their standard auto policy and aren't willing to take the financial risk of driving on track without coverage do have options available. PCA has partnered with Lockton Affinity, the administrator of the HPDE Insurance Program. The PCA – HPDE Insurance Program offers single-event physical damage insurance at a very affordable rate. The premiums are based on value, and the average premium for our members is \$205 per event. When applying, PCA members can enter their member number to receive a 10% discount on their premium!

Do not assume that you still have coverage while participating in DEs based off of research or questions asked to your agent years ago. Before your next event, check your policy and go to that event knowing whether you will or will not be covered in the case of an unfortunate incident that causes damage to one of your most prized possessions. If your research shows that you do not have coverage, consider getting supplemental through the PCA – HPDE Insurance Program:

### MISSION STATEMENT

We start our career on our first track day. We feel that we have mastered our Porsche and want to take our skills to the track. Some random instructor gets in the passenger seat and tells you how much you don't know. You are nervous and excited but feel you have the skills to conquer this new sport.

Your instructor is calm and talks in your ear explaining what the line means, what brake points mean and the apex. In my opinion the instructor should give you a line to learn the basics and understand the track. This is not the racing line or a qualifying line at all. This is a line to get comfortable with the car and the speeds. This is a safe line that will give you room for error in case you haven't mastered the braking zone or corner entry point. As your skills progress we give you more of our speed secrets.

David Murry once used a quote that I have always used. "The driver went in deep and ran out of talent".

You must walk before you run. If you drive the racing line without the skills and run wide out of a corner you will run out of talent.

Derek Bell once told me that a driver hit the wall when he got a little behind in his steering.

Again this was a comment when someone didn't have the experience and skills to manage the car on the race line and at the speed they found themselves. Most instructed drivers have complained for many years that "their last instructor never showed me that line". This might be that your instructor of the day sees your new level and will show you more of an aggressive line. This is a complement when you are fed a more aggressive line.

"The driver went in deep and ran out of talent". You must walk before you run. If you drive the racing line without the skills and run wide out of a corner you will run out of talent.

As you develop through the ranks we teach drivers everything from right to left at each track to late braking and trail braking to race craft in the black and instructor groups. I am going to make it a point to make every class this year about "speed secrets". You will learn car control and technique in every classroom. I will try to be stern to keep your lesson equal to your ability and "age appropriate".

Please always feel free to ask questions in our classes and we will try to keep you excited about learning.

This is one of the most exciting sports in the world but it can be dangerous. Let's learn to keep it within our ability and learn to grow.




### RALLY — IT'S NOT JUST THE CARS, IT'S THE INSTRUCTIONS!

We are absolutely blessed by wonderful twisties (twisty = wonderful sports car road) almost everywhere in Connecticut. That makes both setting up a CVR rally easy, and guarantees the event will be enjoyable. Whether you decipher all the traps on the rally or not, you will have an enjoyable 2 hour drive in your Porsche, and then get to eat lunch and visit with others who just drove the same roads. Even better, your spouse, significant other, son, daughter, grandchild or whomever you want can share the morning with you. Fun to be sure, but as perfectionists, we are going for more than fun. We will add some history of the area, a presentation about the place we begin and end the rally and some mental challenges to track or solve. That, I hypothesize, surpasses fun and borders on fulfillment, or fun with meaning. Come join other CVRers for our two coursemarker rallies this year (June 9th in Storrs and October 27th somewhere in the gold coast) and see for yourself.

OK, if you are thinking, oh please!, perhaps I may be getting a little carried away... but the club hasn't had a rally for quite some time, so 'scuse my enthusiasm. Come out and prove me wrong!

The June 9th rally will start in the new downtown Storrs (if you haven't been to Storrs in a while, you won't believe the transformation), run out through Mansfield into Ashford, Willington, back into northern Mansfield, through a sliver of Coventry and end up in Mansfield once again. It should take about 2 to  $2\frac{1}{2}$  hours to complete with a 3 hour maximum.

are Route Instructions (RIs) which are the "turn here or turn there or go straight" instructions defining the basic rally route. Then there are Supplemental Instructions (Supps) which are usually associated with numbered and lettered coursemarkers (CMs) you will see along the rally route. When you see a coursemarker, for example CM "A-3", you then look on the page of Supps you received along with the Route Instructions and Scoresheet, and follow these new instructions. They might tell you to turn around (at the next safe location to do so), ignore/delete/skip the RI vou are working on and go on to the next RI. Finally, there are Special Instructions (SIs) that may be given out at checkpoints or can appear anywhere in any of the other instructions. SIs are the highest level instructions in the rally (except of course traffic laws and the Rallymaster's personal instructions).

Unlike some rallies, the use of GPSs will be welcomed. If they help you find roads that are called out in the instructions, that is fine. Of course, a GPS won't help you figure out which road you should leave an intersection on, but that's what the GIs are for. The rallies will also have "free zones" absent of any traps, in case you and your copilot need a break to relax and just enjoy the drive.

Of course, the rally will have some traps – probably only about a dozen. These will be places along the rally route where you will have a choice of which way to proceed. If you have read the instructions carefully, and follow their correct priority, you will know the right way to go – but even if you go the "not so right" way, you should be able to execute the next instruction and thus complete the rally as if you did indeed figure out all the traps. A critique, complete with visual aids showing each trap and how the rally route was intended to be driven will be available at the finish. As commonly utilized in gimmick rallies, there will also be some observations you will be asked to make along the rally route. Some of these will count towards your score and some will just be tie-breakers. There will be a place for these on the scoresheet.

Dash plaques will be given to all participants and the top finishers in each class. For the first rally there will just be 3 classes – beginners with no experience, novices with a little rally experience, and everyone who has a reasonable amount of rally experience.

Registrations are already coming in for the first rally, and we are limited to 20 or 25 rally teams, so if you are interested, send in your registration soon.

The June 9th event will be "Course Following" (non TSD) Rally. PCA members in Porsches only due to limited space at the finish. 18 years minimum age for drivers (no age requirement for navigators/passengers). Drivers must be licensed and all participants must sign a waiver.

aerospace grade aluminum. His expertise in wheel manufacture was evident in his detailed presentation of Formula 43's design, manufacturing and quality control processes. He explained that the rotary forged center section begins life as a cylinder of billet. The billet is then heated and placed into a die in the rotary forging machine. The die spins the billet at 300 rpm

while the billet is pressed from above at a 5 degree angle. The material then flows in a circular pattern into the die. The new forging is then heat-treated, quenched and aged to exacting standards. The end result is a rotary forged center section that has stiffer spoke dimensions, lighter weight and a quicker moment of inertia. Equally impressive was Travis's precise answers to the many highly technical questions from the audience.

Once again, the CVR membership proved that weather is no deterrent to good fun, satisfying food, the latest in technology and design and access to top rated products.




the folder like a kid expecting a college acceptance letter. YES, an invitation from Mr. Warner! Florida in early March, warm weather – here we come!

Tommy Kendall with the SRT Vipers, had brought up how much more competitive it is now then when he was last racing, a one-second difference in lap times was the margin between 1st and 2nd place for qualifying then and today qualifying was a onesecond difference between the 1st place car all the way down to the 8th place car.

This year Paul Miller Racing has Bryce Miller and Marco Holzer driving with Richard Lietz in for the longer races. For Falken Racing you have Wolf Henzler, Bryan Sellers and new Porsche driver Nick Tandy, who won the 2012 Porsche Cup Championship and the 2011 Porsche Carrera Cup Deutschland Championship and is the new 10th Porsche Factory Driver. Wolf Henzler and I have something in common and it is on Wolf's helmet, ask me next time you see me.

The race started at 10:30am and with a clean start, and the race continuds with little contact between cars and only four yellow flags during the whole race, which meant pushing the team, car and drivers to an all-out sprint mode.

As usual, you have to be running at the end to compete for the finish and so were the two Porsche teams with a 3rd place podium for team Falken and a 6th place for Paul Miller Racing. A respectable finish for both teams as many other teams would have liked to finish at either of these two positions this year.

Paul Miller was racing as high as 2nd place, but during the yellow flags was unlucky and lost two laps, otherwise they would have been on the lead lap as they were still turning lap times the same as the leaders at the end.

Falken Racing started with a disappointing qualifying which made them have to race through the pack more determined for the team to do well. While Bryan Sellers had limited seat time leading up to race day, it took raw persistence for the two Porsche factory drivers, and Bryan Sellers the Falken factory driver, to make their way through the field. Sellers passed a BMW with three hours remaining and held that position until the end of the race. The Falken team spent less time in pit lane than any other GT team.

In GTC the Alex Job Weathertech Porsche with Cooper MacNeil, Jeroen Bleekemolen and my friend Dion von Moltke (who won with CVR member Mike Piera at Lime Rock two years ago) won the GTC class. Dion also won the GT class at the 24 hours of Daytona this year so now I refer to him as the Rolex Man.

We also have a new Porsche GTC entry that some of you might have noticed. It's a team called Dempsey Del Piero Racing with drivers Andy Lally, Joe Foster and some actor named Patrick Dempsey. Just look for the line for autographs, which


started more than an hour before the autograph signing was scheduled, and you'll find this team. They did well, as Andy Lally took the pole in the final seconds of qualifying in the #27 Tully's Coffee entry, and he also led in the first hour of the race. The #27 had an accident at the halfway point when Foster crashed coming out of turn 17, Sebring's fast final corner leading into the front straight. Foster was uninjured and the team quickly repaired the car and then picked up two spots in the final 90 minutes to finish in 6th place. It was a great effort by a new team. I will have to watch this team closely this year.

Corvette won the GT class with Ferrari in 2nd and the Falken Porsche in 3rd.

In GTC, 1st place went to Alex Job Racing, 2nd to TRG and 3rd to NGT/Momo.

I hope to see some of my Porsche friends at the 2014 12 hours of Sebring or at any other CVR or Porsche event this year.

The new United SportsCar Racing series will keep IMSA as the sanctioning body and may include some DTM type cars in 2015. So, I will keep you informed in this new racing year and upcoming new series.




From a Porsche enthusiast's perspective, some of this years more interesting vehicles included:


The all new 911 GT3, with an incredible 475 HP engine, a controversial new PDK gearbox, fully adjustable chassis, 4-wheel steering, it's packed with technology so sophisticated that it is even banned in Formula One racing. Porsche has taken a racecar-like approach to its engineering, resulting in a benchmark time around the legendary Nürburgring racetrack that has stunned its competitors. The GT3 car sets a new standard for sports car driving intensity.

2013 also marks the 50th Anniversary of the Porsche 911. As a fitting tribute, sitting alongside the GT3 at the Porsche display is Jerry Seinfeld's 1964 Porsche 911. Mr. Seinfeld's vintage, gray Porsche only produces 130 HP from its 2.0 liter flat 6, but easily tops the GT3 in value as this may be the first Porsche officially designated "911". Originally owned by Ferry Porsche designer, engineer and son of the company's founder before trading hands across multiple continents. Mr. Seinfeld bought the car in 1996. The Porsche factory in Zuffenhausen, Germany, performed a meticulous two-year restoration that they estimated would cost \$250,000. It was shown at the Pebble Beach Concours in 1998, and Mr. Seinfeld regularly drives it in New York and California.



### THE FIRST COFFEE RUN OF THE SEASON TO KENT FALLS STATE PARK

Well, the long winter is finally over and the first Coffee Run of the 2013 driving season is here, scheduled for Saturday, May 11, 2013.

We will meet in Stamford at about 8:30 a.m. to sign in, and after a brief driver & navigator meeting, we will be heading northward over some beautiful scenic Connecticut back-country roads on a journey to Kent Falls State Park. The distance from Stamford to Kent Falls is approximately 100 miles and the return route approximately 60 miles. There will be a rest stop 27 miles into the run and the lunch venue will be at a luncheonette in the Kent area.

Kent Falls is a series of waterfalls on Falls Brook in the park, a tributary of the Housatonic River. The falls drop 250 feet in under a quarter mile. There is a walking trail that runs upward along Falls Brook giving a spectacular view of the falls. It is not a difficult walk, but the stairs are quite steep.



The town of Kent is 5 miles south of Kent Falls State Park and offers some nice galleries and shops to browse.





# ND ARCHITECTURE OF THE PORSCHE MUSEUM



New special exhibition until 26 May 2013

Stuttgart. Ever since it first opened in 2009, the Porsche Museum has fascinated visitors with its combination of unique vehicles and stunning architecture. From now until 26 May 2013, a special exhibition staged by the sports automobile manufacturer will show the making of what is probably the most spectacular architectural project in the history of the company. For the first time, diverse exhibits and technical drawings will explain how the museum came into being and present the structural challenges involved in its creation.

#### BUILT IN ZUFFENHAUSEN

"Built in Zuffenhausen" will be centred around the design by Delugan Meissl Associated Architects of Vienna, winner of the architects' competition in 2005. Visitors to the special exhibition will also learn more about the construction techniques employed for the museum from a selection of material samples. Plans and models submitted by the architectural practices which participated in the competition can likewise be admired --- some of them never before seen in public.

The simple facts and figures about the museum building are equally impressive. More tons of steel were used to build the Porsche Museum, for instance, than the Eiffel Tower in Paris. The monolithic body, weighing 35,000 tons, rises 45 metres above Porsche Square and is supported on a highly complex steel skeleton. Resting on just three V-shaped columns, the museum's dominant main structure appears to hover in mid-air. Its central location on Porsche Square reflects the close ties with the sports automobile manufacturer and its Zuffenhausen headquarters. Today, the Porsche Museum is a centre

"Built in Zuffenhausen" is being used as an opportunity to supplement the one-hour architectural tour with a visit to the special exhibition. At 3 p.m. on Wednesdays and Sundays, visitors can take advantage of an extended themed tour covering both the museum itself and the special exhibition at a price of four euros per person (on top of the normal cost).





#### Porsche Boxster and Cayman named 2013 World Performance Cars

Top Awards given at the New York Motor Show

#### Stuttgart – 28/March 2013

At a ceremony hosted by Bridgestone Corporation at the New York Auto Show this morning, the Porsche Boxster and Cayman were named the 2013 World Performance Car. The Cayman celebrated its world premiere only last November at the International Motor Show

in Los Angeles, while the Boxster has been on the market now for a year.

The World Car Awards (WCA) are presented annually in four categories — Car Design, Green Car, Performance Car and Car of the Year. Winners are determined by an international panel of 66 automotive journalists from 23 countries. Jurors are appointed by the World Car Steering Committee based on automotive expertise,

experience, credibility and influence.

Since the inception of the World Car of the Year Awards, Porsche has won World Performance Car twice; for the 911 (2012) and for the Cayman (2006).

In the USA, Canada, Russia, South Africa, Singapore and Germany too — since the start of the year Porsche sports cars have received some 20 awards in countries all around the globe.

In Germany the Porsche 911 in its Carrera 4 version was recently voted 'Best All-Wheel Drive Car' in the coupé/cabriolet category by the readers of Auto Bild, fighting off strong competition to win. Over 100,000 readers and Internet users took part in the annual reader survey.

Commenting on the success of the Porsche models, Matthias Müller, President and CEO of Dr. Ing. h.c. F. Porsche AG said: "The Porsche 911 is winning award after award in its anniversary year. Even after five decades, its concept still excels through top dynamic handling, efficiency and extreme emotion. The new Boxster and Cayman also possess innate 911 DNA, with which they impress customers and jurors alike. That makes us very proud."

As the Carrera the Porsche 911 delivers 350 PS and as the Carrera S exactly 400. The 911 reaches speeds of up to 304 km/h. The car's weight has gone down by up to 40 kilograms and fuel consumption by up to 16 per cent. The base prices for the Porsche 911 Carrera start at 90,417 Euro, (\$115779. USD) including value added tax.

The Porsche roadster, the Boxster, has been making headlines since March 2012 and provides a thrilling open-top experience. The flat six engine in the Boxster delivers 265 PS, while in the Boxster S drivers have 315 PS at their disposal. The base prices start at 49,243 Euro, (\$63,056. USD) including value added tax.

As an outstanding performer around corners, it is above all dynamic flair that the new Porsche Cayman exudes. There are two versions of this mid-engine sports car as well: the Cayman with a 275-PS flat engine and the Cayman S delivering 325 PS. This agile cornering ace is available from 51,385 Euro, (\$65,798. USD) including value added tax.
